

Reduce energy costs with a reflective roof



Typically, homes with dark-colored flat roofs or concrete tile roofs absorb more of the sun's heat, resulting in higher energy costs. Take advantage of FPL rebates to put a reflective coating on your roof. Your home will be cooler and your energy costs will be lower.

Reduce cooling costs

One way to reduce energy costs is to apply heat-reflecting roofing materials to your existing roof. Heat-reflecting roofing materials will reflect 73 percent or more of the sun's heat away from your home, resulting in lower cooling costs. If you decide to install a reflective roof, FPL might be able to help offset the installation costs.

How to qualify for a rebate from FPL

FPL can help lower the cost of installing a reflective roof coating. Thermoplastic membranes and roof coatings with a minimum solar reflectance of 73 percent qualify for an FPL incentive of 50 cents per square foot.

To qualify for the Reflective Roof incentive, you must

- » Use an FPL Participating Independent Contractor*
- » Have ceiling/roof insulation with an R-value of R-19 or less
- » Have a roof with a solar reflectance of less than 40 percent
- » Use qualifying roofing materials

Qualifying roofing materials include

- » Light-colored thermoplastic roof membranes or reflective roof coatings that are ENERGY STAR® compliant or Cool Roof Council rated
- » Coating or membranes with an initial solar reflectance of 73 percent or more
